ADMITTED HORSES & SANITARY + INSURANCE RULES

The "ACME® PROSPECTS & STALLIONS PRESENTATION 2025" is reserved to 1 or 2 years old horses and to stallions not entered in any 2025 Futurity & Championships show classes. Horse owners assure that the horse(s) is free of any contagious diseases, properly vaccinated according to Italian regulations and laws and carries public liability insurance at the time the horse arrives at the show grounds. Horse owners are aware of that they are personally liable of any damages caused by the horse if there is no liability insurance. The horse owners shall indemnify and hold harmless show organizer against any claims or legal proceedings brought by third parties.

Horse owners declare under them personal responsibility to have taken out insurance policy to cover any damage suffered by me and or / them horse as well as any damage, injury or personal injury caused by them and / or them horse / to third parties during the event. Any lack or insufficiency of the aforementioned insurance policy will entail, on my part, the loss of the right to formulate claims for damages against the Organizing Committee. However, Horse owners undertake to address any claims for damages suffered by themselves and / or them horses during the event exclusively towards them insurance or third parties other than the Organizing Committee, exempting from all responsibility the Organizing Committee and all its managers and representatives for any accident or injury suffered by them and or / them horse, as well as for any damage caused by them or them / them horse / third parties (injuries, personal injury and 'other) during the event, including the present as a waiver of the right of action against the Organizing Committee, as well as any requests for indemnity, regression or guarantee against them for events that occurred during the event.

In consideration of the participation in the ACME® PROSPECTS & STALLIONS PRESENTATION 2025 event, horse owners authorize the Organizing Committee of the event to process the personal and sensitive data pursuant to and for the purposes of Legislative Decree 196/2003 and of the European regulation 679/2016, also expressly authorizing them to publish and / or record, in any form and / or on any media (for example, internet sites, social media, printed media, video streaming, etc.), of photographic material and videos made.

Dogs must be kept on a leash. Services available during the presentation: blacksmith, health care, veterinary care.

The organization is not responsible for theft of personal items of the participants, even inside the vehicles parked in the internal areas provided. The internal parking of cars, caravans or trucks (pitches with water and electric connections) and all means of transport of horses, will be regulated by the following rates:

Car € 25,00 - Trucks or Car/Trailer combination € 60,00 - Parking with electric plug (3Kw) € 220,00. It is MANDATORY to register all the vehicles before the show on the PRIORITY LINE section in the website futurity.it.

The arrival of the horses can only take place starting from 2 pm to 7 pm From Wednesday 05 November 2025.
